from which:

An alder tree, 16 inches in diam., bears S 60° W, 21.0 feet. scribe marks S 10 BT exposed.

An alder tree, 18 inches in diam., bears N 22° E, a distance of 4.4 feet, the scribe marks 1 N 7 W S2 B not grown over yet:

as described in State Highway Notes on file in the Tillamook County Surveyors Office.

A stone 12 X 9 X 6 inches, in place, with 2 notches on north and 3 notches on south and marked WC, bears S 05° E, a distance of 30.7 ft.

The original field notes call the corner to be north of witness stone a distance of 33.0 ft. (50 lks) and the State Highway notes state the pipe was set north a distance of 33.0 ft. The slope distance from the witness stone to the pipe I find to be 33.0 ft. This distance should be horizontal measurement. Therefore

At a point 33.0 feet North of the witness stone:

Set a $1\frac{1}{2}$ inch iron pipe, 3 feet long, with an Oregon State Board of Forestry bronze cap stamped: T1N R7W S3 S2 S10 S11 1951 199.

from which:

The 12 inch iron pipe bears S 45° W, a distance of 3.8 feet.

An alder tree, 14 inches in diam., bears N 46° W, a distance of 55.0 feet, scribed: TlN R7W S3 199 BT.

Placed a metal location poster on a 16 inch alder and marked it: Sec 10 TlN R7W Sec Cor 24.0 Ft. S 62° W.

Placed a mound of stone 1 foot high, 12 feet in diam., around the corner.

The point for corner determined by the remains of the original bearing trees.

A fir stump, 40 inches in diam., bears N 44° E, a distance of 19.1 ft. (29 lks), scribe marks 1/ & part of 4 exposed.

No evidence of hemlock Br.

The point for corner falls in the middle of a cat road.

GG7/10 A witness corner, at a point worth a distance of 15.0 feet.

Set a 1½ inch iron pipe, 3 feet long, with an Oregon State Board of Forestry bronze cap stamped: WC 2 S 20 S21 15 ft. S 1951 199.

from which:

A fir stub, 42 inches in diam., bears S 40° W, a distance of 23.5 feet, scribed: $\frac{1}{4}$ S21 BT 199.

A fir stump, 58 inches in diam., bears N 41° W, a distance of 33.7 feet, scribed: # S20 BH 199.

Placed a metal location poster on the 40 inch fir stump BT & marked it: Sec 21 TlN R7W $\frac{1}{4}$ Cor 19.1 ft. S44° W.

Restoration of the corner to sections 20, 21, 28, & 29, Township 1 North, Range 7 West, W.M., Tillamook County, Oregon.

The point for corner determined from the remains of the original bearing trees.

A fir stump, 41 inches in diam., bears S 59° W, a distance of 13.0 ft., scribe marks BT exposed. (The original notes call for this distance to be 12.5 ft. /I9 lks/).

A hemlock stub, 31 inches in diem., bears N 65° E, a distance of 19.7 ft., old face not exposed. (The original notes call for this distance to be 19.1 ft. $\sqrt{29}$ lks).

At the point for corner:

Set a 1½ inch iron pipe, 3 feet long, with an Oregon State Board of Forestry bronze cap stamped: TlN R7W S20 S21 S29 S28 1951 199.

from which:

A fir snag, 41 inches in diam., bears S 30° E, a distance of 29.5 feet, scribed: TlN R7W S28 BT 199.

Placed a metal location poster on the 41 inch fir stump BT and marked it: Sec 29 TlN R7W Sec. Cor. 13.0 Ft. N 59° E.
