


Dependent Resurvey of a Portion of the W. Bdy. of T. 1 S., R. 8 W.

Chains	Descend 213 ft. over NW. slope.
24.70	Top of bluff, 20 ft. high, edge bears N. 70° E. and S. 70° W.; descend 103 ft. over N. slope.
26.61	The $\frac{1}{4}$ sec. cor. of Section 6 only, determined at record bearing and distance from the remaining original bearing tree, recorded and monumented by the Oregon State Board of Forestry with an iron post, $\frac{1}{2}$ in. diam., protruding 3 ins. above ground, firmly set, in a mound of stone, 3 ft. base, to top, with 3 in. bronze cap mkt.

	from which the original bearing tree:
	A rotted spruce stump and log, 40 ins. diam., bears N. 72° E., 19 lks. dist., with scribe marks $\frac{1}{4}$ S BT visible on rotted and opened blaze on log lying 30 lks. north of stump.
	and a tree marked by the Oregon State Board of Forestry in 1955:
	A hemlock, 17 ins. diam., bears N. 46° E., 41 lks. dist., with scribe marks $\frac{1}{4}$ S6 BT RE2311 visible on partially healed blaze.
	Add marks BLM 1959 to the bronze cap and mark a new bearing tree:
	An alder, 8 ins. diam., bears N. 87° E., 90 $\frac{1}{2}$ lks. dist., bark scribed $\frac{1}{4}$ S6 BT.

	N. 5° 13' W., beginning new measurement.
	Descend 50 ft. over N. slope.
2.50	Little North Fork of Wilson River, 100 lks. wide, course W.; ascend 443 ft. over S. slope, along the E. edge of live old growth timber.
15.87	Point for the closing corner of Sections 1 and 12, on the E. bdy. of T. 1 S., R. 9 W., hereinafter described.
	Ascend 102 ft. over steep rocky SE. slope.
19.50	Spur, slopes SW.; descend 415 ft. over broken W. slope.
46.00	White Creek, 30 lks. wide, course SW. curving to S.; ascend 244 ft. over SE. slope.
58.42	Point for the $\frac{1}{4}$ sec. cor. of Section 1 only, on the E. bdy. of T. 1 S., R. 9 W., hereinafter described.
	Ascend 187 ft. over SE. slope.
67.00	Spur, slopes E.; descend 286 ft. over NE. slope.
87.00	White Creek, 20 lks. wide, course SE.; ascend 10 ft. over S. slope.
96.00	Creek, 10 lks. wide, course SW.; ascend 333 ft. over S. slope.
98.00	Spur, slopes S. 30° W.; descend 58 ft. over NW. slope.
100.21	Intersect the S. bdy. of T. 1 N., R. 8 W.
