

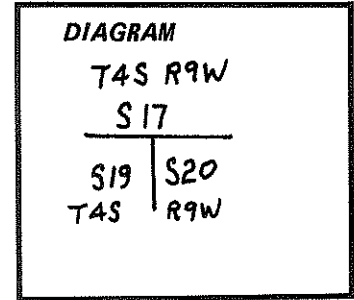
**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

**History of original corner establishment:**

Corner established by Henry Meldrum, Deputy Surveyor, Contract No. 301, dated Sept. 13, 1878. Original survey states:

Set cedar post 4-1/2 ft. long, 4" sq., for cor. to Secs. 17, 18, 19 and 20; from which:

- A fir, 30" diam., bears N65°E, 86 lks. dist.
- A cedar, 18" diam., bears S86°E, 140 lks. dist.
- A cedar, 24" diam., bears N23°W, 131 lks. dist.
- A willow, 4" diam., bears S40°W, 77 lks. dist.



Corner is common to Sec. 19 and 20 only because of a closing corner T4S, R9W, to Sec. 17 and 18. Set by Charles E. Branson, Deputy Surveyor, Contract No. 687, June 8, 1898.

M. Whitmore, Deputy Surveyor, Tillamook Co., perpetuated and recorded this corner on June 7, 1961.

**Description of corner evidence found:**

1-1/2" diam. pipe 2 ft. above ground, set by M. Whitmore June 7, 1961.

26" alder, S24°30'E, 22.5, scribed: S20 BT, set by M. Whitmore June 7, 1961.

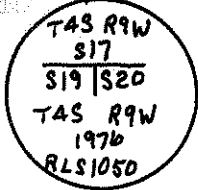
20" alder, S31°W, 21.5 ft., set by M. Whitmore, June 7, 1961, is missing.

M. Whitmore found intersecting line blazes at the location of the iron pipe.

He also found a 30" fir snag N65°E, 86 lks.  
 18" cedar stump S86°E, 140 lks.  
 No remains of original BT's left.

**Description of monument and accessories established to perpetuate the original location of this corner:**

Set 2-1/2" brass cap 6" above ground.  
 Set 1-1/2" diam. iron pipe by cap extending 2-1/2 ft. above the ground.



BT S24°30'E, 22.5 ft. was scribed at breast height and barely visible, so I re-bark scribed the BT at the base, S20 BT.

(1 June 1976) New BT: Alder 20" diam., brs. S27°W, 60.2 ft., bark scribed: T4S R9W S19 BT. Brass washer stamped "RLS 1050" placed at base of B.T., by D. Schildan.

Painted 6" red band around BT's.  
 6' metal fence post with attention sign attached set 4' west of cor.  
 New BT tags set on BT's.  
 Attention signs on back of BT's.
