

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Reference:
Plat dated July 1973
by Timberland Services
Inc. under my stamp.

History of original corner establishment:

This corner was set by Albert P. Wilson under contract No. 555 dated June 25, 1890. He located this corner 79.60 chs. N. 0° 04 1/2' W. of the corner to $\frac{6}{7} \frac{5}{8}$. At that time he set a post:

"79.60 chs. Intersect 1st standard parallel S., 2.63 chs. E of old corner to Secs. 5, 6, 31, 32 which is a staone, set in the ground, 16" X 10" X 6" from which:

A Spruce, 9 ins diam., bears N. 20° W. 6 lks.
mkd "T 6 S R 10 W S 31 BT"

At point of intersection, I set post 4 in. sq., 4 ft. long, 24 in. in ground, for closing corner to secs 5 & 6, mkd. "CC T 6 S R 10 W S 6 on S., S 6 on W and S 5 on E face with 1 notch on W & 5 on E; from which:

an Alder, 12" diam. bears S 32° E 32 lks.
mkd "T 6 S R 10 W S 5 BT"

Description of corner evidence found:

A Spruce, 16" diam, bears S 10° W 15 lks
mkd "T 6 S R 10 W S 6 BT"
An Alder, 5" diam, bears N 17° E 26 lks.
mkd "T 6 S R 10 W CC S 5 & 6"

November 6, 1890"

I found a 3/4" pipe standing 20" above ground at the corner point. The SW BT is now a rotted stump. The SE BT is an uproot and the NE BT is gone.

Description of monument and accessories established to perpetuate the original location of this corner

I set a 2 1/2" X 30" galvanized iron pipe with a flared bottom and a brasscap riveted to the top marked: T 5 S R 10 W On the township line between the Section Corner to the west and the 1/4 Corner to the east,

From which:

- 30" Rotted Spruce stump bears S 10° W 13.9'
mkd "BT" visible (original BT)
- 10" Spruce bears S 31° W 15.4'
mkd "T 6 S R 10 W S 6 CC BT"
- 10" Hemlock bears S 39° E 19.3'
mkd "T 6 S R 10 W S 5 CC BT"
- 3/4" iron pipe bears N 01° 49' 22" E 3.95'

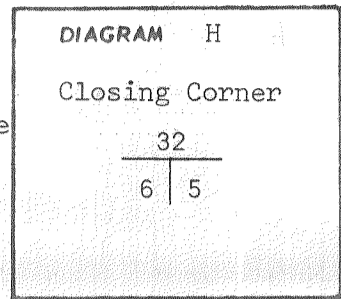
