I SET A 5/8" REBAR WITH A 3" DIAMETER TILLAMOOK COUNTY SURVEYOR BRASS CAP, STAMPED AS SHOWN HEREON, IN ANCHORING CEMENT AND FLUSH WITH THE PAVEMENT IN OREGON COAST HIGHWAY 101. THIS MONUMENT HAS BEEN RESET FROM TIES SET PRIOR TO OREGON DEPARTMENT OF TRANSPORTATION HIGHWAY CONSTRUCTION.

HISTORY OF FOUND MONUMENT

THE MONUMENT AS DESCRIBED ON REWITNESS CARD #211 WAS DESTROYED BY HIGHWAY CONSTRUCTION. A MONUMENT SPIKE WAS SET AS A TEMPORARY MARKER AT THE POSITION OF THE ONE-QUARTER CORNER WHICH IS BEING REPLACED BY A 3" DIAMETER BRASS CAP DESCRIBED BY THIS RESTORATION.

THE BASIS OF BEARING FOR THIS RESTORATION HAS BEEN ESTABLISHED BY HOLDING MONUMENTS 109 AND 43 FROM MAP B-2442, TILLAMOOK COUNTY SURVEY RECORDS.

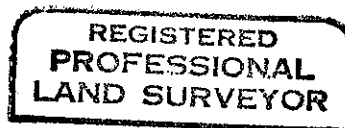

LOCATION OF MONUMENT

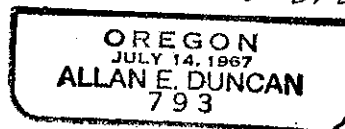
THIS ONE-QUARTER CORNER IS LOCATED IN A REFUGE LANE IN THE OREGON COAST HIGHWAY 101, ± 69 FEET WEST OF THE EAST CURB FACE AND ± 3' FEET NORTH OF THE EASTERLY EXTENSION OF THE CENTERLINE OF GOODSPEED COUNTY ROAD.
