NARRATIVE: Purpose of survey is to blaze and monument those boundaries shown thus \_\_\_\_\_\_\_ on the annexed survey plat.

Basis of bearings is true bearings as determined from observations of Polaris taken at latitude 45° 47.0' north and longitude 123° 44.3' west.

Held position of found original G.L.O. quarter corners on the south boundaries of Sections 34 and 36; and the positions of found G.L.O. line trees on the south boundaries of Section 34, 35, and 36; and reestablished the lost intervening section corners and quarter corner by single proportionate measurement between said found corners and line trees as per sections 5-18 and 5-34 of the Manual of Surveying Instructions 1973 and section 375 of the Manual of Surveying Instructions 1947.

For the following two reasons, I did not accept the positions of the south boundaries of Sections 34, 35, and 36 as established by the Oregon State Board of Forestry in 1966 and recorded on Clatsop County Survey C-777 and Tillamook County Survey B-510:

The quarter corner common to Sections 3 and 34, accepted

by the State and recorded in Clatsop County B.T. Record 273-18 and Survey 7828, and Tillamook County B.T. Record Book 2, Page 595 and Book 6, Page 249, is erroneous and does not monument the original position of said corner as established by Manius Buchanan in 1891. The original position for this corner was restored by me in April 1983 and is shown as corner 73 on the annexed plat.

2. The state either ignored or did not find any of the five large line trees reported on line between the quarter corner common to Section 3 and 34, and the quarter corner common to Sections 1 and 36. I have found four of the five line trees, and as shown on the annexed plat, the distance and angular relationships between them are very good. They are all the correct species, and given allowances for time, their diameters are within acceptable limits and their positions agree well with the G.L.O. topographic calls. There are no other qualified candidates within a 50-foot radius of each identified line tree. There were no notches found on any of the line trees, but the absence of notches can be explained by the loss in diameter due to decay and the passage of time. The absence of notches does not necessarily disqualify all line tree candidates any more than the absence of scribing disqualifies all bearing tree candidates. The physical evidence of each tree, and the corroborative evidence of distance and angular measurements and topography calls, definitely identifies

each of the found subject trees as original line trees.

Section 5-18 of the Manual of Surveying

Instructions 1973 prescribes: "Under the law, a

definitely identified line tree is a monument of the

original survey. It properly is used as a control point
in the reestablishment of lost corners by the

appropriate method of proportionate measurement."

Held positions of found and established corners and subdivided Sections 35 and 36 as prescribed in Sections 3-87 and 3-89 of the <u>Manual of Surveying Instructions</u> 1973.

This procedure holds the alignment of the senior Buchanan survey, and it provides for the latitudinal positioning of the lost corner by single proportionate measurement between the nearest identified corners on opposite sides of the lost corner using the most recent measurements reported in the junior Meldrum survey.

This procedure is in conformance with the regulations set forth in Section 372 of the <u>Manual of Surveying Instructions 1947</u> and Section 5-35(3) of the <u>Manual of Surveying Instructions 1973.</u>

At the position shown on the annexed plat and described above, I set 36" in the ground a 2" x 36" G.I.P. with a fully stamped 2-5/8" brass cap from which bearing trees set by the State in 1966 and recorded on Clatsop County Survey 777 bear as follows: A 52" spruce with overgrown face bears S 65° W 48.60 feet to a 3/4" brass disk stamped "LS 849" nailed to small blaze. A 19" hemlock with fully overgrown face bears S 65° W 48.60 feet to 3/4" brass disk stamped "LS 849" nailed to small blaze. I scribed two new B.T.'s as follows: A 9" alder bears N 57° E 9.80 feet, and a twin 14" alder bears S 57° E 36.50 feet. Set 6 foot steel fence post with location poster two feet north.
