## History, condition, and sources

(BLM Field notes 1857) A scribed post was set for the section corner and two bearing trees established. In 1961 (Rewitness Bk. 1, pg. 492) W. A. Markham set 1" drill bit in place of the scribed post for the Section corner and established one bearing tree. In 1973 (Rewitness Card #125) Tillamook County Surveyor's office set a 2" iron pipe with a 3" Tillamook County brass cap in 10" tile filled with concrete and stamped "T3NR10W S18 S17 S19 S20 RS 287 1973" in place of found 1" drill bit and established two bearing trees. In 1975 (Rewitness Bk. 6 Pg. 166) John Hollingsworth placed parks corner tag on one bearing tree and added a steel post with a corner location tag. In 1994 (Rewitness Card #125) Tillamook County Surveyor's office established two new bearing trees. In 2025 (Field Bk. MR 18 Pg. 3 & 4) the Tillamook County Surveyor's office found a 3" Tillamook County Surveyor's brass disk in tile filled with concrete stamped as shown hereon. The found accessories are listed below.

Found: (Rewitness Card #125 1973: 14" dia. fir N69°E 9.15') (Rewitness Card #125 1994 26" dia. fir.) Now 30" dia. with healed scar and white do not cut tag.

Found: (Rewitness Card #125 1973: 40" dia. fir N76°W 66.95') (Rewitness Card #125 1994: 40" dia.) Now 44" dia. fir with healed scar and white metal do not cut tag.

Found: (Rewitness Card #125 1994: 10" dia. fir S31°W 10.84). Now 20" dia. with healed scar no tag.

Found: (Rewitness Card #125 1994: 27" dia. double fir S55°E 15.29'). Now 30" dia. with healed scar and yellow metal location tag embedded in the tree.

Found (Rewitness Card #125 1973: 72" hat section post North 1.5') (Rewitness Card #125 1994 North 2.5'). Now at the location of Rewitness Card #125 1994.
