

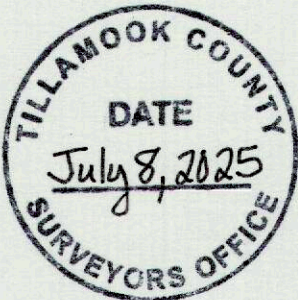

History, condition, and sources In 1979 (B-873) John Carlich the Tillamook County Surveyor set a 2" iron pipe with a 3" brass cap in 10" tile and concrete stamped "CN 1/16 SEC 12 RS 287 1979" and established 2 bearing trees. In 1979 (Rewitness Card #455) the Tillamook County Surveyor's office wrote up the corner in the Rewitness card files. In 2025 (Field Bk. MR 18 Pg. 5-6) the Tillamook County Surveyor's office found a 3" Tillamook County brass cap in tile and concrete stamped as shown hereon. Found accessories are listed below. Found: (Rewitness Card #455: 8" dia. spruce S82°W 24.27'), Now 21" dia. spruce with healed scar but no metal location tag. Found: (Rewitness Card #455: 8" dia. spruce N01°E 36.50'), Now badly rotted windfall with yellow metal location tag.		
New accessories set: The corner was tied conventionally using GPS established control in Oregon North Zone NAD 83/91 grid coordinates in US survey feet. Coordinates are provided here in WGS 84 Latitude and Longitude. Latitude: 45°24'57.91965" Longitude: -123°51'17.59970" 25" dia. double spruce N84°W 7.2' scribed "T2SR10WCN1/16BT" with a nail and a washer between the scribed BT with a yellow metal location tag.
