### History, condition, and sources

In 1857 (BLM-Oregon Field Notes) a post was set for the Meander Corner along the line of Sections 7, T.2S, R9W and Section 12, T.2S, R.10W, and two bearing trees were established. In 1929 (Rewitness Bk.4 Pg.36) W.E Anderson established a new bearing tree. In 1949 (Rewitness Bk.4 Pg.52) W.E Anderson established three new accessories. In 1964 (Rewitness Bk.4 Pg.101) W.E Anderson establishes three new accessories. In 1973 (Karl E. Foeste Field Bk. Sect.1, Pg.8) Karl E. Foeste set a 5/8" iron bolt for the Meander Corner. In 1978 (Rewitness Card #365) Tillamook County Surveyor's Office replaced the 5/8" iron bolt with a 2" iron pipe with a 3" Tillamook County Brass Cap in tile with concrete stamped "MC S12 S7 2S10 2S9 RS 287 1978" and established three new accessories. In 2025 (MR Field Bk.18 Pg.13-14) the Tillamook County Surveyor's Office found a 3" Tillamook County Brass Cap in concrete stamped as shown hereon. Found accessories are listed below.

Found: (Rewitness Bk.4 Pg.36: 30" dia. spruce S76°30'E 61.2') (Rewitness Card #365: fell in old channel of creek) Now Found in slough.

Found: (Rewitness Bk.4 Pg.52: 30" dia. spruce N76°15'E 199.37') Now uprooted

Found: (Rewitness Card #365: treated fence post S21°W 4.80') Now at Location with Metal Location Tag


Found: (Rewitness Card #365: 86" hat section post East 17.30) Reset at East 13.65'
