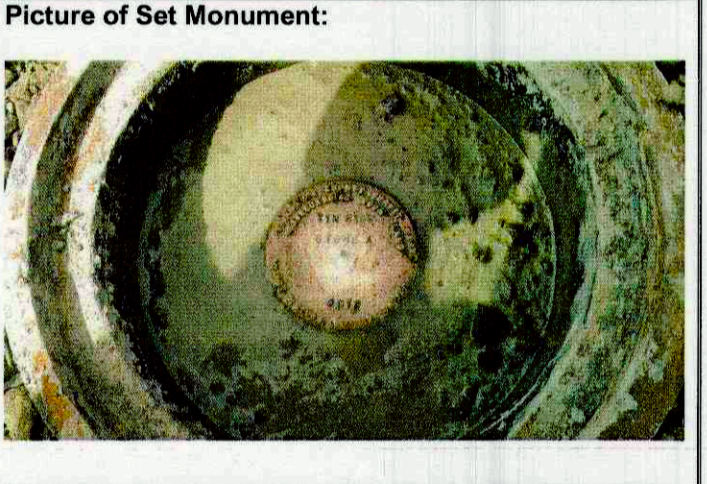

Found Monument(s) and Accessories (Condition & Source): Stone 'A' was originally set in 1882 and then reset by the County Surveyor in 1886. In 1969, the Tillamook County Surveyor found a 1-1/2" diameter iron pipe in a concrete tile which was held as "Stone A" by John Carlich, L.S. 287 (see Rewitness Card #47). This point was torn out in 2015 by utility construction along the southerly edge of Bay Lane road. The corner accessories listed on Rewitness Card #47 are all missing.

Monument Set (Procedures and Description): The monument was reset using GPS coordinates obtained by GPS observations for work done by the Tillamook County Surveyor's Office on May 05, 2001. The observation is recorded in field book "F", GPS Unit 2545, 3-13-01 to 4-10-03. We set a 3" diameter Tillamook County Surveyor Brass cap in a cast iron monument box and concrete stamped "T1N R10W STONE A 2016", and as shown hereon.

New accessories set: Set a small PK nail at the entrance to an existing concrete ramp. The PK nail bears South 78° West 18.3' from the monument. Set a hat section post with a yellow metal location tag which bears South 5'. The southwest corner of house number 1208 Bay Lane Road which bears North 25° East 39.7'.

New Bearing Trees set: No new bearing trees were set as there are no suitable trees in this area.

Location & Comments: The corner is located approximately 24 feet North of the centerline of the existing railroad tracks and along the southerly edge of Bay Lane Road.
