

GASB 77 Disclosure for Tillamook County

FY 2025/26 — Estimated Tax Abatement

This only applies for Taxing Districts in Code 9.00 and Code 9.11

The Tillamook County Assessor & Tax Collector has determined that the only qualifying abatements in the county are for three properties located within the Tillamook County String of Pearls Enterprise Zone.

Authorization for exemption is per ORS 285C.050-250.

- **Tax Code 9.00: Estimated exempt assessed value of \$414,190; approximate tax reduction of \$4,959**
- **Tax Code 9.11: Estimated exempt assessed value of \$1,274,140; approximate tax reduction of \$12,958**
