

2020/21 GASB 77 - Tillamook County estimated tax to be abated - for disclosure purposes only

This only applies for Taxing Districts in Code 9.00 and Code 9.38-see Summary below:

Tillamook County Assessor & Tax Collector has determined the only abatement that qualifies in Tillamook County is two code areas with the exact same tax rates in the Tillamook County String of Pearls Enterprise Zone.

Authorization for exemption is per ORS 285C.050-250.

Code 9.00 and Code 9.38 Exempt Assessed Value is estimated at \$1,472,830 with \$17,524 estimated tax reduction.
