

MODIFICATION #1 TO
TITLE III GRANT AGREEMENT #5010
TILLAMOOK COUNTY AND OREGON DEPARTMENT OF FORESTRY

This Grant Agreement Modification, hereafter "modification #1", is made and entered into, by and between Tillamook County, a political subdivision of the State of Oregon, acting by and through its Board of Commissioners, hereinafter "County" and the OREGON DEPARTMENT OF FORESTRY, hereafter "Recipient". The parties entered into a Title III Grant Agreement on June 5, 2019. The parties intend this modification to modify their earlier agreement only as to their expressions herein. The mutual promises of each are given in exchange and as consideration for, the promises of the other.

2. AGREEMENT PRICE & AMOUNT

The price for the services and/or goods provided by Recipient shall be ~~Fifty Thousand and 00/100 Dollars (\$50,000.00)~~ *One Hundred Thousand and 00/100 Dollars (\$100,000.00)*. Subject to the terms and conditions of this Agreement, county shall disburse the grant funds to Recipient on an expense-reimbursement basis only after county's receipt and approval of invoices and project reports outlining expenses incurred from Recipient.

All provisions of the underlying agreement not otherwise modified by this document remain in full force and effect and are incorporated herein by reference.
