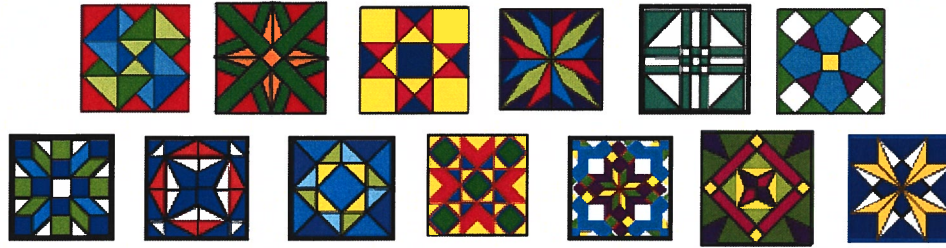


Tillamook County Quilt Trail

We are requesting these are signed and returned by July 6, 2021.

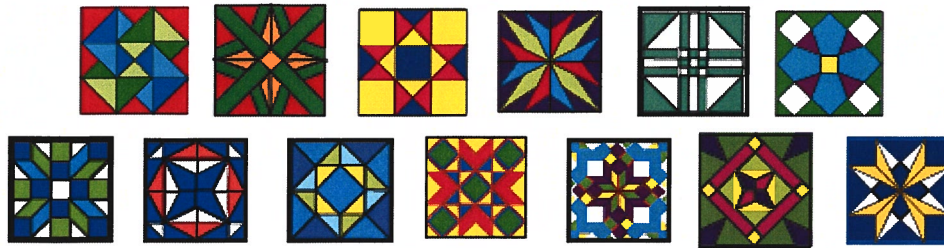

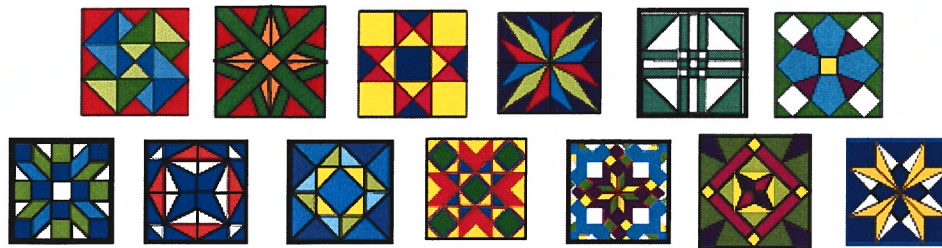

Your quilt block(s) and site location(s) are in place under past approval by the original Tillamook County Quilt Trail Coalition. By signing below, you are agreeing to accept the following conditions and requirements:

- ☐ The quilt block will be visible from the road.
- ☐ The quilt block must be square in design and not smaller than 4' x 4' nor larger than 8' x 8'.
- ☐ The quilt block will remain at this at least through the end of the 2025 calendar year.
- ☐ If/when the block is removed, I will notify Tillamook Coast Visitors Association immediately.
- ☐ The quilt block is my property and its maintenance and long-term upkeep is my responsibility.
- ☐ If I change the color / design of the original block, I will notify Tillamook Coast Visitors Association immediately, and provide a current image.
- ☐ I understand that having a quilt block as part of the Tillamook County Quilt Trail may increase traffic and/or visitors to site location.
- ☐ I will allow my quilt block to be photographed by the public and photos to be used in advertising and promotional materials by the Tillamook County Quilt Trail and Tillamook Coast Visitors Association.
- ☐ I will allow my name and/or my business name to be used by the Tillamook County Quilt Trail in advertising and promotional materials.
- ☐ I agree to indemnify and hold harmless the Tillamook Coast Visitors Association, -(dba Visit Tillamook Coast), as well as its officers, committees, agents, volunteers and employees for and against any and all claims, liabilities, losses and causes of action related to the quilt block and quilt trail.
