Safety Committee)

This matter came before the Board of Commissioners for Tillamook County, Oregon this 31st day of July, 2013 at a regular meeting of the Board at which time it appears that the County's Insurance carrier, City-County Insurance Services, has recommended that each of the safety committees established for individual facilities be abolished and a singular county-wide safety committee be established. Being fully apprised of the records and files herein, the Board finds as follows.

1. In 1989 the Board of Commissioners established safety committees for the Courthouse, Library and Museum (Order #89-71), Public Works and Parks (Order #89-72) and the Sheriff, Jail and Marine Program (Order #89-73).
2. A separate safety committee was created for the County Health Department in 2000 (Order #00-24).
3. On August 12, 2008 the Board of Commissioners delegated to the Human Resources Director the task of appointing members to the various safety committees.
4. As part of a recent Risk Management Plan Development for Tillamook County by City-County Insurance Services (CIS), the recommendation was made that the individual safety committees for each county facility be abolished and that a singular safety committee covering all county facilities be established.
5. The rationale for the CIS recommendation is based on the recognition that a single committee comprised of qualified and specially trained personnel will provide a more effective, uniform and comprehensive approach to risk management.

NOW, THEREFORE, IT IS HEREBY ORDERED that:

6. The hereinabove described safety committees and delegated appointment authority, together with all other Orders, Resolutions and board actions in conflict herewith, be and are hereby repealed.

7. There is hereby established a new county-wide safety committee comprised of a designee from each of the following departments or locations: Public Works, County Health and Human Services, County Courthouse, County Library, County Parks, Sheriff's Office, Community Development, and Surveyor's Office.
8. This committee will serve at the pleasure of the Board of Commissioners.
9. All members serving on this committee shall receive and maintain the certifications and training required by OSHA and CIS.
10. This Order shall become effective August 1, 2013.
