Caption: City of Rockaway Beach City Charter Amendment

Question: Shall the City of Rockaway Beach amend the existing City Charter?

Summary: The Rockaway Beach City Charter defines the City's governmental structure, the powers and responsibilities of elected and appointed officials, and procedures for elections and City legislation.

If passed, the Charter would be amended as follows:

- Explicitly recognize the City's "home rule" power
- Remove the Mayor/Councilor responsibility related to "heads of departments" to align with Council-Manager form of government
- Stagger terms of City elected officials so that approximately half of the positions are up for the election each general election
- Change the Mayor's term from 2 years to 4 years, beginning with the 2030 election
- State that Mayor and Councilor offices vacant upon incumbent's death, adjudicated incompetence, or recall
- Add that a municipal judge may commit to jail or admit to bail anyone accused of a City offense
- Change formatting, delete repeated text, and make grammatical and cross-referenced edits

The City Council referred this measure to the voters. Charter amendments require voter approval. A complete copy of the proposed Charter amendment is available at City Hall and at www.rockawaybeachoregon.gov.
