- 1. The current fee schedule set forth in this order has not been revised since November 30, 2011 under Board Order 11-089 and since July 17, 2013 under Board Order 13-065.
- The current fee schedule does not accurately reflect the current costs of providing desirable levels of service to the residents and property owners of Tillamook County.
- 3. The fees for the Building Division of Community Development need to be increased to improve cost recovery for the provision of necessary and required services to process and issue permits.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 4. The fee schedule shall be revised as set forth in the attached Exhibit A, which is incorporated herein by reference as though set forth in full.
- 5. This order shall become effective July 15, 2023.
