Notice is hereby given that the Tillamook County Board of Commissioners will hold a public hearing on December 13, 2023, beginning at 10:00am, at the Board of County Commissioners Meeting Room 106 in Tillamook, Oregon, 201 Laurel Avenue, to consider the following:

**Road Rename Request #851-23-000486-PLNG:** An application has been filed with the Tillamook County Department of Community Development at the request of the Tillamook County Public Works Department to rename the Cape Kiwanda beach access to “Dorymen’s Way”. Located within Section 24AA, Township 4 South, Range 11 West of the Willamette Meridian, Tillamook County, Oregon, the road connects Cape Kiwanda Drive to the dory launch ramp in Pacific City. The applicant is the Tillamook County Public Works Department.
