1. A public hearing on said proposed budget was held on March 19, 2025, per the requirements of Oregon Budget Law.

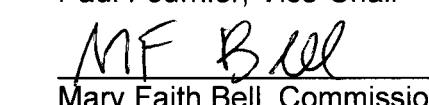
NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

3. The amounts for the Fiscal Year 2024-2025 Supplemental Budget and for the purposes shown on Exhibit "A" are hereby appropriated.

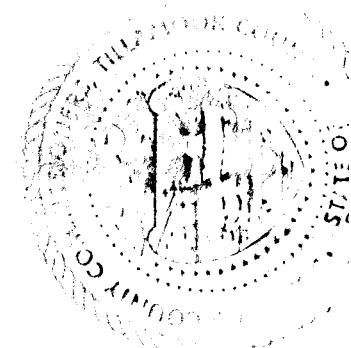

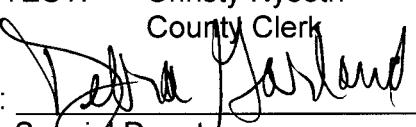

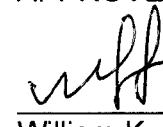
