This matter came before the Tillamook County Board of Commissioners on April 30, 2025 at the request of Chris Laity, Director of Tillamook County Public Works Department, for a notice of intent to award a contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:


1. Tillamook County advertised its call for bids in the Daily Journal of Commerce on March 24, 2025 and the Headlight Herald on March 25, 2025. Therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed eight (8) copies of its bid solicitation documents in response to all potential bidder requests for copies.
3. Tillamook County received no questions during the call for bids period.
4. Tillamook County received three (3) timely responsible bids.
5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the contract to the responsible bidder submitting the most advantageous, responsive bid.
6. The bid of ROAD & DRIVEWAY COMPANY in the amount of Four-Hundred Thousand and 00/100 Dollars (\$400,000.00) for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

7. Notice of intent to award a Contract for Goods for the Tillamook County 2025 Asphalt Procurement be and is hereby adopted. The board's administrative analyst is directed to promptly send by e-mail, a copy of this order to the successful bidder and all plan holders who provided an address.
8. This notice shall constitute a final decision of Tillamook County if no written protest of the notice of award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within seven (7) calendar days of the date of this notice of award pursuant to local contracting rules.

9. ROAD & DRIVEWAY COMPANY shall submit the required insurance certificates and executed contract in order that a signed contract is presented to the Board of Commissioners at its regular meeting on May 7, 2025.
10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.
