DEFUTY

The Board of Commissioners of Tillamook County, Oregon ordains as follows:

Section 1.

Section 107.3 is amended as follows:

107.3 The Planning Department shall be responsible for designating addresses on any new residential or commercial building, mobile home placement, and recreation vehicle placement permits as they are issued and denoting said number on the appropriate house numbering map.

Section 2.

Section 108 is amended as follows:

108.1 If the residential or commercial building, mobile home, or recreation vehicle CAN be seen from the main named roadway, the property owner shall locate the house number, assigned to them by the Tillamook County Planning Department, where it can be visably seen from the named main road. The numbers shall be no less than 4" high and of proportionate width. The numbers shall be of a contrasting color to the structure.

If the structure CANNOT be seen from the main named roadway, the property owner shall set an identification post with a house number sign at the entrance of the unnamed roadway where it intersects with the main named road. The identification post shall be no less than 4" x 4" and 6 feet in length. It shall be placed one and one-half feet into the ground. The post shall be placed beyond any of the named roadway shoulders and/or ditches The house number sign shall be no less than 5 1/2" x 20" and shall be black in color. The house numbers, as described above, shall be placed on both sides of the house number sign, and the sign attached to the post so that the numbers can be seen by traffic riding along the main road in both directions. The numbers shall be white and of reflective material.

In addition to the identification post and house number sign the property owner shall locate the house numbers on the residential or commercial building, mobile home, or recreation vehicle where they can be seen from the unnamed roadway, specifications to be the same as stated in paragraph 1 of this section.

The Building Inspector or Planning Department may require larger numbers if they feel that it necessary to do so. 108.2 If more than two residential or commercial buildings, mobile homes or recreation vehicles, or any combination thereof, are located on an unnamed roadway, either private or public, prior to any additional residential or commercial building, mobile home or recreation vehicle building or placement permit being issued, the property owner shall have the roadway named, in accordance with the Geographic Names Board Ordinance. After the roadway is named, new house numbers will be assigned according to the House Numbering Grid System.

Section 3.

This ordinance being necessary for the immediate preservation of the public health, safety and welfare of the residents of Tillamook County, an emergency is declared to exist and this ordinance amendment shall take effect immediately upon its adoption.
