IN THE COUNTY COURT OF THE STATE OF OREGON
FOR THE COUNTY OF TILLAMOOK

IN THE MATTER OF PROVIDING BY ORDINANCE FOR CURFEW RESTRICTION AS FOLLOWS: PROHIBITING PERSONS UNDER CERTAIN AGES TO BE UPON, OR LOITER UPON ANY STREET, HIGHWAY, ALLEY, AVENUE, PARK OR ANY OTHER PUBLIC PLACE OF TILLAMOOK COUNTY EXCEPTING AREAS WITHIN A CITY AFTER CERTAIN HOURS, AND PROHIBITING PARENTS FROM ALLOWING PERSONS UNDER CERTAIN AGES TO BE UPON, OR LOITER UPON ANY STREET, HIGHWAY, ALLEY, AVENUE, PARK OR ANY OTHER PUBLIC PLACE OF TILLAMOOK COUNTY EXCEPTING AREAS WITHIN A CITY AFTER CERTAIN HOURS, UNLESS SUCH CHILD OR CHILDREN UNDER CERTAIN AGES SHALL BE ACCOMPANIED BY HIS OR HER PARENTS, LEGAL GUARDIAN OR OTHER ADULT PERSON LAWFULLY ACCOMPANYING SUCH PERSON, AND AUTHORIZING ANY POLICE OFFICER TO TAKE CHARGE OF PERSONS UNDER CERTAIN AGES VIOLATING THIS ORDINANCE, AND TAKE SAID PERSONS TO ANY POLICE STATION, SHERIFF'S OFFICE OR STATE POLICE OFFICE AND NOTIFYING THEIR PARENTS TO COME AND GET SAID PERSON AND PROVIDING A PENALTY FOR REFUSAL OF THE PARENT TO COME AND GET SAID PERSON WHEN SO NOTIFIED AND FURTHER PROVIDING A PENALTY FOR ANY PARENT OR GUARDIAN WHO, AFTER NOTIFICATION OF THE VIOLATION OF THIS ORDINANCE BY PERSONS UNDER CERTAIN AGES, IN HIS CARE ALLOWS SAID PERSON TO VIOLATE THIS ORDINANCE A SECOND TIME, AND PROVIDING A PENALTY, AND DECLARING AN EMERGENCY.

AN ORDINANCE ESTABLISHING CURFEW ON MINORS WITHIN ALL AREAS OF TILLAMOOK COUNTY EXCEPTING CITIES

The County Court of Tillamook County, State of Oregon, does hereby provide by this Ordinance for curfew restrictions on minors applicable to all areas within Tillamook County but not within a city, as follows:

Section 1. It shall be unlawful for any person under the age of 18 years to be upon any street, highway, alley, avenue, park or any other public place of Tillamook County, excepting areas within a city, after the hour of 10:30 P.M., unless such person shall be accompanied by a parent, legal guardian or any other adult person lawfully and properly accompanying such minor person, provided that persons 18 years of age and under 18 years may be upon any street, highway, avenue, alley, park or any other public place of Tillamook County, excepting areas within a city, up to 12:00 midnight on Fridays and Saturdays, subject nevertheless to the provisions and penalties of Section 3 of this ordinance.

Section 2. It shall be unlawful for any parent, legal guardian or any other adult person having the legal care and custody of any minor person under the age of 18 years, to allow or permit any such person to go upon, or be upon any street, highway, alley, avenue, park or any other public place of Tillamook County,

excepting areas within a city, after the hours of 10:30 P.M. unless accompanied by a parent or legal guardian or any other adult person lawfully and properly accompanying such minor person, provided that persons 16 years of age and under 18 years may be upon any street, highway, alley, avenue, park, or any other public place of Tillamook County, excepting areas within a city, up to 12:00 midnight on Fridays and Saturdays, subject nevertheless to the provisions and penalties of Section 3 of this ordinance.

Section 3. It shall be unlawful for any person under the age of 18 years to loiter upon any street, highway, alley, avenue, park or public place of Tillamook County, excepting areas within a city, after the hour of 9:00 p.m. unless such person shall be accompanied by a parent, legal guardian, or any other adult person lawfully and properly accompanying such minor person.

Section 4. It shall be unlawful for any parents, legal guardian, or any other adult person having the legal care and custody of any minor person under the age of 18 years, to allow or permit any such person to loiter upon any street, highway, alley, avenue, park or public place of Tillamook County, excepting areas within a city, after the hour of 9:00 p.m. unless such person shall be accompanied by a parent, legal guardian, or any other adult person lawfully and properly accompanying such minor person.

Section 5. Any police officer or any other law enforcement officer is hereby authorized and empowered by virtue of his office to take charge of any persons under the age of 18 years violating the provisions of this ordinance, and it shall be the duty of such officer taking charge of any such person to take such person to any police station, sheriff's office or State police office to thereafter notify the parents or guardian of such person, as soon as possible, of the violation of the terms of this ordinance, and to notify such parent or legal guardian that said minor person will be held in custody at such police station, sheriff's office or state police office until said person can come to the police station, sheriff's office or state police office to get said minor person, and said minor person shall be held at such police station, sheriff's office or state police office pending the arrival of said parent or guardian.

Section 6. It shall be unlawful and shall be considered a separate offense under this ordinance for any parent, guardian, or any other adult person having the

legal care and custody of any person under the age of 18 years to refuse to come to the police station, sheriff's office or state police office and take said minor person under their custody immediately to their home, upon being so notified by the police department, sheriff's office or state police department.

Section 7. It shall be unlawful for any parent, guardian or other adult person having custody of a person under 18 years of age, after having been notified that said person has violated this ordinance, to allow said person to violate this ordinance a second time.


Section 8. Whenever a peace officer learns that a person under 18 years of age has violated this ordinance under circumstances which tend to render him delinquent, the officer shall place an appropriate complaint with the juvenile court for such further proceedings as the court deems appropriate.

Section 9. Any parent, guardian or other adult person having custody of a person under 18 years of age, who shall violate the provisions of this ordinance, shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not more than \$50.00 or by imprisonment in the county jail for a term of not more than 25 days or by both such fine and imprisonment.
