Harbor Drive Boat Launch During the)
COVID-19 Local State of Emergency)

This matter came before the Tillamook County Board of Commissioners on June 10, 2020. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. Under the emergency powers granted by ORS 401.305, on March 14, 2020 the Board of Commissioners signed Resolution #R-20-005 designating a State of Emergency within Tillamook County due to the spread of the Coronavirus (COVID-19).
2. On March 22, 2020 the Board of Commissioners signed Resolution #20-006 continuing the emergency and closing within Tillamook County all county, state, and federal parks, all county parking lots, beach access, and certain parking areas along road rights-of-way, and all county public boat launches to non-commercial users.
3. On May 13, 2020 the Board of Commissioners signed Resolution #20-012 opening the Hungry Harbor Drive boat launch to recreational and commercial dory boat operators during weekdays. The Board approved opening the boat launch to commercial dory boat operators seven (7) days per week through approval of Resolution #20-017 on May 27, 2020.
4. On May 27, 2020 the Board of Commissioners signed Resolution #20-016 continuing the emergency through July 6, 2020.
5. On May 29, 2020 the Board of Commissioners signed Resolution #20-018 opening the Cape Kiwanda parking lot to the public on weekends.
6. Although the emergency still exists, the Board deems it is appropriate to continue a safe and strategic reopening of county facilities.

NOW, THEREFORE, LET IT BE RESOLVED, that the following is effective immediately:

7. The Cape Kiwanda parking lot shall be open to the public seven (7) days per week.
8. The Hungry Harbor Drive boat launch shall be open seven (7) days per week for the operation of motor vehicles used for towing boat trailers or essential to boat launchings in accordance with OAR 736-024-0015(2)(g)(A) and (B). These motor vehicles are also permitted to park on the beach in the areas defined in OAR 736-024-0015(2)(g)(A) and (B).
9. All other motor vehicles are prohibited from using the Hungry Harbor Drive boat launch and parking on the beach per direction from the Oregon Parks and Recreation Department.
10. This resolution in the matter of opening the Cape Kiwanda parking lot and Hungry Harbor boat launch shall remain in effect unless otherwise amended by the Board.
