This matter came before the Board of Commissioners on February 1, 2017 at the request of Sara Charlton, Library Director.

The Board being fully apprised of the records and files herein, finds as follows:

1. The Board of Commissioners of Tillamook County, Oregon (the "County"), has determined that there is a need to renew the five-year Library Operating Local Option Tax.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 2. An election is hereby called for the purpose of submitting to the qualified voters of the County the question of renewing the five-year Library Operating Local\Option Tax.
- 3. The election hereby called shall be held in the County on Tuesday, May 16, 2017. The election shall be conducted pursuant to ORS 254.465 et seq.
- 4. County staff shall cause to be delivered to the County Clerk of the County the attached Notice of Election and Receipt of Ballot Title, not later than 61 days prior to the election. The County Clerk is requested to give the electorate of the County appropriate notice.





NOTICE OF ELECTION & RECEIPT OF BALLOT TITLE

Published pursuant to ORS 255.085 (4b)

Notice is hereby given that a ballot title for a measure referred by the Tillamook County Board of Commissioners has been filed with the County Clerk of Tillamook County, Oregon on <u>Feb l</u>, 2017. The May 16, 2017 Special Election will be conducted by mail pursuant to ORS 254.465. An elector may file a petition for review of this ballot title in Tillamook County Circuit Court no later than 5:00 p.m. February <u>J0</u>, 2017 pursuant to ORS 255.155.

CAPTION: RENEWAL OF FIVE YEAR LIBRARY OPERATING LOCAL OPTION TAX

QUESTION: Shall Tillamook County levy \$0.65 per \$1,000 of assessed value for County Library operations, beginning 07-01-2017 for five years? This measure renews current local option taxes.

SUMMARY: Since 1983 the library has been funded by operating levies. The levy amount will remain at \$0.65 per \$1,000 of assessed value and will be used to continue the operations of the County Library System. It is estimated the proposed rate will raise \$2,870,000 in 2017/18; \$2,956,100 in 2018/19; \$3,044,783 in 2019/20; \$3,136,126 in 2020/21; and \$3,230,210 in 2021/22. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate. The County Library System includes the main library in Tillamook, five branch libraries located in Bay City, Garibaldi, Rockaway Beach, Manzanita, and Pacific City and the Bookmobile which serves rural Tillamook County. This tax rate will provide over 95% of the total revenue supporting the County Library System. All county libraries will have to close if an operating levy fails.
