This matter came before the Board on the 1st day of February, 2017 at a regular meeting of the Tillamook Board of County Commissioners, at which time it appears that on December 7, 2016 and January 11, 2017 the Board entered Order #16-053 and Order #17-003, respectively, on its own motion declaring its intention to initiate and approve the formation of a law enforcement district pursuant to provisions of ORS 451.010(1)(n). Having heard the testimony of witnesses and examined the exhibits presented as part of two public hearings held, and based on the records and files herein, the Board finds as follows:

1. The Board of Commissioners has jurisdiction over this matter pursuant to ORS 198.705 to 198.955 and ORS 451.435(1).
2. The Board of Commissioners' Order #16-053 initiated the formation of a law enforcement district pursuant to the provisions of ORS Chapter 451 to be located entirely within the boundaries of Tillamook County.
3. The name of the proposed law enforcement district shall be the Pacific City-Neskowin Sheriff's Enhanced Patrol District.
4. Pursuant to ORS 451.485 the Board shall be the governing body of the Pacific City-Neskowin Sheriff's Enhanced Patrol District.
5. The boundaries of the proposed law enforcement district shall be that portion of Tillamook County lying within the boundaries of the Pacific City Joint Water-Sanitary Authority and the Neskowin Regional Water District, as more particularly described in the attached Exhibit A, incorporated herein by reference, and as also depicted in the attached Exhibit B, incorporated herein by reference.
6. Pursuant to said Order #16-053 a public hearing was held on January 11, 2017 at which time testimony was received as to whether an election should be called on the proposed formation of said district and whether a permanent property tax rate should be established for said district in the amount of \$0.58 per \$1,000 assessed value.

7. Public notice of the January 11, 2017 hearing was given by publishing the notice of public hearing. The affidavit of publication for the notice of public hearing is attached as Exhibit C, incorporated herein by reference.
8. Additional notice of public hearing was made by posting a notice of hearing in six public places in the vicinity of the proposed formation and at the county courthouse. The affidavit of Susan Corbisiero as to the posting of public hearing is attached as Exhibit D, incorporated herein by reference.
9. Pursuant to said Order #17-003 the second and final public hearing was held on February 1, 2017 at which time testimony was received as to whether an election should be called on the proposed formation of said district and whether a permanent property tax rate should be established for said district in the amount of \$0.58 per \$1,000 assessed value.
10. Public notice of the February 1, 2017 hearing was given by publishing the notice of public hearing. The affidavit of publication for the notice of public hearing is attached as Exhibit E, incorporated herein by reference.
11. There should be an election for the formation of a law enforcement district under and pursuant to ORS Chapter 451 and ORS Chapter 198, for the reason that there are law enforcement needs in the densely populated unincorporated areas of the proposed district, as well as its attraction by tourists.
12. The election should include as part of the same measure the question of the establishment of a permanent tax rate in the amount of \$0.58 per \$1,000 assessed value.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

13. The question of the formation of the Pacific City-Neskowin Sheriff's Enhanced Patrol District and approval of a permanent property tax rate for said district shall be submitted, as a single question, to the voters residing within the boundaries of the proposed district at the special election to be held May 16, 2017.
14. The permanent property tax rate proposed as part of the formation shall be in the amount of \$0.58 per \$1,000 assessed value to be levied beginning in fiscal year 2017-2018.
15. Attached to this Order as Exhibit A is the legal description of the proposed district. The County official in charge of elections shall include with the ballot for the election, a map or other description of the boundaries of the proposed district using streets and other generally recognized features, and a statement of the permanent tax rate proposed for the district. The statement on the ballot shall comply with the requirements of ORS 250.035.

16. Pursuant to the provisions of ORS 198.815(1), the County election official shall cause notice of the election to be published by two insertions in the Headlight Herald, a newspaper of general circulation within the county.
