5. Hannah Palter and Katie Reeder, youth members, are qualified and willing to be appointed to the Wellness Task Force.

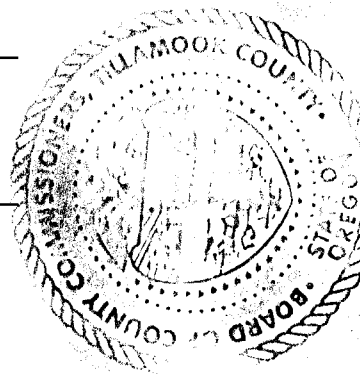
NOW, THEREFORE, IT IS HEREBY ORDERED that:
