County Lands as County Park and)
Recreation Lands) #17-034

This matter came before the Board of Commissioners on April 12, 2017 at the request of Rachel Hagerty, General Services Administrator. The Board being fully apprised of the records and files herein, finds as follows:

1. On August 30, 1935 Tillamook County acquired a tract of land (Parcel 1) from Duncan & Brewer Lumber Co. (Tillamook County Deed Records, Book 71, Page 40).
2. By Order of the County Court on September 23, 1936, said Parcel 1 was ordered to be "...set apart as PUBLIC PARKS and recreational areas" (Tillamook County Deed Records, Book 215, Page 715).
3. On December 24, 1941 Tillamook County acquired through tax foreclosure a tract of land (Parcel 2) adjacent to Parcel 1 (Tillamook County Deed Records, Book 82, Page 227).
4. Said Parcel 2 is not currently set aside or designated for parks and recreational purposes, but should be dedicated for such purposes as part of this present Order.
5. The County has the authority to designate public parks and recreational areas under ORS 275.320.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

6. Parcel 2, as more particularly described in the attached Exhibit A incorporated herein by reference, be and is hereby set aside for County park and recreational purposes.

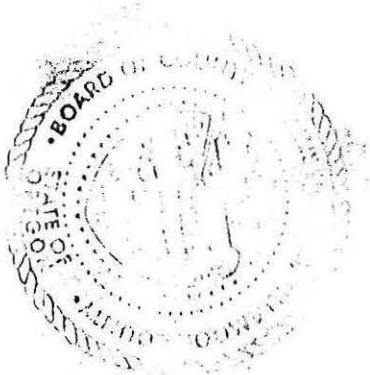
