This matter came before the Tillamook County Board of Commissioners on April 26, 2017 at the request of Rachel Hagerty, General Services Administrator. Being fully apprised of the records and files herein, the Board finds as follows:

- 1. On January 20, 1941, Tillamook County acquired by deed from the Hammond Lumber Company a tract of land (Deed Book 80, page 243).
- 2. On April 9, 1941, the Tillamook County Court set aside and dedicated said tract by order for the purposes of parks and recreation (County Court Order, Book P, Page 242; recorded in Deed Book 215, page 719).
- 3. On December 29, 1975, the County acquired an additional triangular-shaped property adjoining said tract (Deed Book 244, Page 44), which was dedicated for park and recreation purposes in Order #05-107, dated July 6, 2005.
- 4. On November 23, 2005, pursuant to Order #05-107, the County conveyed the lands described in Exhibit A to the City of Garibaldi (Tillamook County Deed Record #2005-010726), subject to the condition that said lands be used by the City solely for park and recreation purposes.
- 5. The City of Garibaldi has no intentions to use said lands for park and recreation purposes. The City deeded said lands back to the County on March 20, 2017 (Tillamook County Deed Record #2017-001740).
- 6. ORS 275.330(2) and (3) authorizes the sale of lands dedicated for park and recreation with the proceeds to be held for maintenance and improvement of existing park and recreation lands or future acquisition of lands to be set aside for park or recreational purposes.
- 7. On April 26, 2017 the Board conducted a public hearing pursuant to ORS 275.330(3) for the purpose of hearing objections to the sale of said lands.
- 8. Notice of said public hearing was published for two consecutive weeks (April 12 and 19, 2017) in the Headlight Herald, a newspaper of general circulation within

- the county, as required by ORS 275.330(3). The Affidavit of Publication is attached as Exhibit B and is incorporated herein by reference.
- 9. The Board hereby determines pursuant to ORS 275.330(2) that an alienation, sale, or conveyance of the lands described in Exhibit A is in the best public interest.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 10. The surplus park and recreation lands described in Exhibit A be and are hereby authorized for alienation, sale, or conveyance pursuant to ORS Chapters 271 and 275 as appropriate.
- 11. This Order shall be recorded in the Tillamook County deed records to memorialize the extinguishments of prior declarations for park and recreation or otherwise.


