ORDER #17- 10

This matter came before the Tillamook County Board of Commissioners on December 27, 2017 at which time it appears that Tillamook City Manager Paul Wyntergreen has requested that the Board undertake proceedings for the formation of a Mid-County Park and Recreation District for an area that is presently the boundaries of Tillamook School District No. 9.

The Board, being fully apprised of the representations of the above-named person, records and files herein, finds as follows:

- 1. The Board intends to initiate the formation of a Park and Recreation District to be located entirely within the boundaries of Tillamook County.
- 2. The Board intends to initiate the formation of a Park and Recreation District under and pursuant to ORS Chapter 266 Park and Recreation Districts and ORS Chapter 198 Special Districts Generally.
- 3. The name of the proposed Park and Recreation District shall be the Mid-County Park and Recreation District.
- 4. The boundaries of the proposed Park and Recreation District shall be identical to the exterior boundaries of Tillamook School District No. 9, as more particularly described in the attached Exhibit A, incorporated herein by reference.
- 5. The Board intends to hold a public hearing on the proposal on Wednesday, January 31, 2018 at 10:30 a.m. in the Commissioners' Meeting Room A in the Tillamook County Courthouse, 201 Laurel Avenue, Tillamook, Oregon.
- 6. The Board finds that a certified copy of the resolution of the governing body of the City of Tillamook is attached hereto as Exhibit B, incorporated herein by reference, and that the City of Tillamook approved this order initiating the formation of the Mid-County Park and Recreation District pursuant to ORS 198.835(3).
- 7. The Board does not intend to call for a formation election for the Mid-County Park and Recreation District as there is no permanent tax rate being created.
- 8. An economic feasibility statement pursuant to ORS 198.749 is not required as there is no permanent tax rate being created.

9. In accordance with ORS Chapter 198, all formation proceedings for the Park and Recreation District shall be initiated, conducted, and completed as provided by ORS 198.705 to 198.955.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 10. It is the intention of the Board of Commissioners to initiate the formation of a Park and Recreation District pursuant to the provisions of ORS Chapter 266 - Park and Recreation Districts and ORS Chapter 198 - Special Districts Generally; and
- 11. The name of the proposed district shall be the Mid-County Park and Recreation District and its boundaries shall be as described in Exhibit A, attached hereto; and
- 12. Public notice be given that a public hearing shall be held on Wednesday, January 31, 2018 at 10:30 a.m. in the Commissioners' Meeting Room A in the Tillamook County Courthouse, 201 Laurel Avenue, Tillamook, Oregon; and
- 13. A formation election for such district will not be called.

Section 1:

City approves and consents to be included within the boundaries of the Mid-County Park and Recreation District, contingent upon the District's subsequent lawful formation.

Section 2:

A certified copy of this resolution shall be delivered to the County Board to accompany the petition for formation pursuant to ORS 198.835 (3).

Section 3:

Resolution 1454 and Resolution 1456 are repealed in their entirety.
