In the Matter of Changing Customer and Franchise Rates for Municipal Solid Waste Disposal at the Tillamook, ) Pacific City, and Manzanita Transfer Stations

ORDER #18-<u>036</u> SWSD #18- <u>006</u>

This matter came before the Tillamook County Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD), on March 28, 2018, at the request of David McCall, Tillamook County Solid Waste Program Manager.

The Board of Commissioners, being fully apprised of the representations of the above-named person, and the records and files herein, finds as follows:

- In accordance with Ordinance #4, Section 5.01 B.c., the Board may by ordinance 1. or order establish rates for disposal sites that are uniform throughout the county or different rates for each site or class of sites.
- Tipping fees for trash, yard debris, and asphalt shingles disposal at the 2. Tillamook, Manzanita, and Pacific City Transfer Stations are established by this governing body and were last changed on March 22, 2017 by Order #17-026, SWSD Order #17-003.
- The Tillamook County Solid Waste Advisory Committee (SWAC) at its March 13, 3. 2018 meeting voted to recommend the adjustment of acceptance (tipping) fees for trash (municipal solid waste) charged at the Tillamook, Pacific City, and Manzanita Transfer Stations, as outlined below.
- The proposed tipping fees would be: 4.
  - A. Garbage/Municipal Solid Waste:
    - i. \$78.27 per ton for franchise haulers
    - ii. \$94.86 per ton for self-haulers to the Tillamook Transfer Station with a \$19.00 (up to 400 lb.) minimum fee
    - iii. \$110.00 per ton for self-haulers to the Pacific City Transfer Station with a \$9.00 minimum fee (up to 164 lb.)
    - iv. \$110.00 per ton for self-haulers to the Manzanita Transfer Station with a \$8.25 minimum fee (up to 150 lb.)
  - B. Yard debris no changes:
    - i. \$70.00 per ton for franchise haulers
    - ii. \$80.00 per ton for self-haulers to the Tillamook Transfer Station with a \$10.00 (250 lb.) minimum fee
    - iii. \$12.00 per cubic yard for self-haulers to the Pacific City Transfer Station, or \$90.00 per ton if calculated by weight

- iv. \$12.00 per cubic yard for self-haulers to the Manzanita Transfer Station, or \$90.00 per ton if calculated by weight
- C. Asphalt roofing waste no changes:
  - i. \$65.00 per ton for franchise haulers
  - ii. \$75.00 per ton for self-haulers to the Tillamook Transfer Station with a \$10 (267 lbs.) minimum fee
  - iii. \$85.00 per ton for self-haulers to the Manzanita Transfer Station
  - iv. \$85.00 per ton for self-haulers to the Pacific City Transfer Station
- 5. The Tillamook County Board of Commissioners finds that the proposed rate will be just, fair, reasonable, and sufficient to provide the proper service to the public.

NOW THEREFORE, IT IS HEREBY ORDERED that:

- 6. Effective July 1, 2018, the fees charged for the disposal of solid waste at the Tillamook County Transfer Stations shall be established as follows:
  - A. Tillamook Transfer Station:
    - i. Garbage/Municipal Solid Waste:
      - 1. \$78.27 per ton for franchise haulers
      - 2. \$94.86 per ton for self-haulers with a \$19.00 (up to 400 lbs.) minimum fee
    - ii. Yard Debris:
      - 1. \$70.00 per ton for franchise haulers
      - 2. \$80.00 per ton for self-haulers with a \$10.00 minimum fee (250 lbs.)
    - iii. Asphalt Roofing Waste:
      - 1. \$65.00 per ton for franchise haulers;
      - 2. \$75.00 per ton for self-haulers with a \$10.00 minimum fee (267 lbs.)
  - B. Pacific City Transfer Station:
    - i. Garbage/Municipal Solid Waste: \$110.00 per ton for self-haulers with a \$9.00 minimum fee (up to 164 lbs.)
    - ii. Yard Debris: \$12.00 per cubic yard for self-haulers, or \$90.00 per ton if calculated by weight
    - iii. Asphalt Roofing Waste: \$85.00 per ton for selfhaulers
  - C. Manzanita Transfer Station:
    - i. Garbage/Municipal Solid Waste: \$110.00 per ton for self-haulers with a \$8.25 minimum fee (150 lbs.)
    - ii. Yard Debris: \$12.00 per cubic yard for self-haulers, or \$90.00 per ton if calculated by weight
    - iii. Asphalt Roofing Waste: \$85.00 per ton for selfhaulers
