ORDER #18-04-2

This matter came before the Board of Commissioners under a Petition of the Pacific Sand Heights Subdivision to withdraw certain real property from the Neskowin Regional Sanitary Authority, and the Board having heard the testimony of witnesses given as part of a public hearing on March 28, 2018, and being fully apprised of the, premises, representations, records, and files herein, finds as follows:

- The Board of Commissioners has jurisdiction over this matter pursuant to ORS 198.795. Sanitary Authority District withdrawals are governed by ORS 198.870 – 198.882.
- 2. The property proposed for withdrawal is more particularly described in the attached Exhibit A, incorporated herein by reference.
- 3. At the conclusion of said public hearing on March 28, 2018, the Board executed Order #18-038 calling a final public hearing to be held on April 18, 2018, and declaring that if written requests for an election were not filed as provided by ORS 198.875(2), the Board, at the time of the final hearing, would enter its order withdrawing the real property incorporated herein by reference from the Neskowin Regional Sanitary Authority.
- 4. Notice of said final public hearing was published in the Headlight Herald, a newspaper of general circulation within the county, in accordance with ORS 198.810(2). The affidavit of publication for the notice of said final public hearing is attached as Exhibit B and incorporated by reference to this Order.
- 5. There was an insufficient number of written requests for an election on the question of the proposed withdrawal from the district filed, as provided by ORS 198.875(2), at the time of or before the final hearing.
- 6. The property proposed to be withdrawn lies entirely within the unincorporated area of Tillamook County.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

7. Pursuant to ORS 198.875(1), the Board of Commissioners withdraws the land and territory in the area known as the Pacific Sand Heights Subdivision as more particularly described in the attached Exhibit A, incorporated herein by reference, from the Neskowin Regional Sanitary Authority as there was an insufficient
