This matter came before the Tillamook County Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD), on May 23, 2018, at the request of David McCall, Solid Waste Program Manager.

The Board of Commissioners, being fully apprised of the representations of the above-named person, and the records and files herein, finds as follows:

1. CARTM has requested to amend the hours the Manzanita Transfer Station is open to the public.
2. The Tillamook County Solid Waste Advisory Committee recommended at their meeting on May 8, 2018 that the request be approved.
3. The Solid Waste Administrator believes that instituting the above hours is consistent with the overall goals established by the Solid Waste Advisory Committee; maintaining customer service, equity, recovery and recycling efforts, and uniformity throughout the County.
4. The Tillamook County Board of Commissioners finds that the proposed operating hours will be just, fair, reasonable, and sufficient to provide the proper service to the public.

NOW, THEREFORE, IT IS HEREBY ORDERED that:

5. Effective May 28, 2018, the hours of operation for recycling and the disposal of solid waste at the Manzanita Transfer Station shall be as follows:

Summer (Memorial Day through Labor Day):

- Monday: 10:00 a.m. – 1:00 p.m.
- Tuesday and Wednesday: Closed
- Thursday – Sunday: 10:00 a.m. – 4:00 p.m. (no change)


Winter (Labor Day through Memorial Day):

- Monday – Wednesday: Closed
- Thursday – Sunday: 10:00 a.m. – 4:00 p.m. (no change)


- 6. The Manzanita Transfer Station will be closed on Memorial Day.
- 7. In the future, the Solid Waste Administrator is permitted to approve changes in operating hours at the Manzanita Transfer Station as necessary.




