The Board of Commissioners, being fully apprised of the representations of the above-named person, and records and files herein, finds as follows:




3. The following transfers of budgeted line items be and are hereby implemented as shown on Exhibit "A" hereto in the amount stated herein.



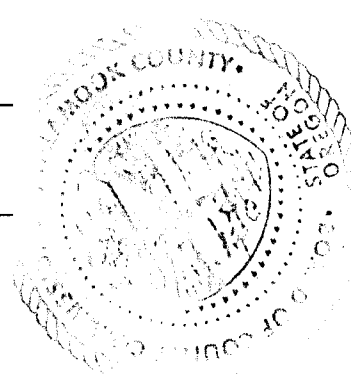
