This matter came before the Tillamook County Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD) on July 25, 2018 at the request of David McCall, Solid Waste Program Manager.

The Board of Commissioners, being fully apprised of the representations of the above-named person, and the records and files herein, finds as follows:


1. Walker Waste Solutions, LLC, dba City Sanitary Service has requested an approval of rates charged by a collection franchisee to their customers in certain pocket service areas.
2. In accordance with Ordinance #4, Section 5.01 B. b., the Board may by ordinance or order establish rates that are uniform within zones based upon the length of haul to disposal sites, concentration of customers and other factors which may, in the opinion of the Board, justify establishment of rate differentials.
3. Rates for trash collection and disposal by solid waste collection franchisees are established by this governing body and were last changed for City Sanitary Service on May 23, 2018 by Order #18-051, SWSD Order #18-009. A rate for a proposed curbside recycling collection route was included with that request.
4. The Tillamook County Solid Waste Advisory Committee at its July 10, 2018 meeting, voted to recommend the approval of the proposed service for a curbside commingled recycling collection service within pocket service areas of City Sanitary Service's franchise area.
5. The curbside commingled recycling collection route will be implemented beginning September 1, 2018.
6. City Sanitary Service has organized and undertaken this service independently of the County's infrastructure and assumes responsibility for all costs and responsibilities associated with this service.
7. The proposed rates will be just, fair, reasonable, and sufficient to provide the proper service to the public.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

8. The City Sanitary Service proposal for the pocket service areas and rates outlined on Exhibit "A" are approved and become effective September 1, 2018.



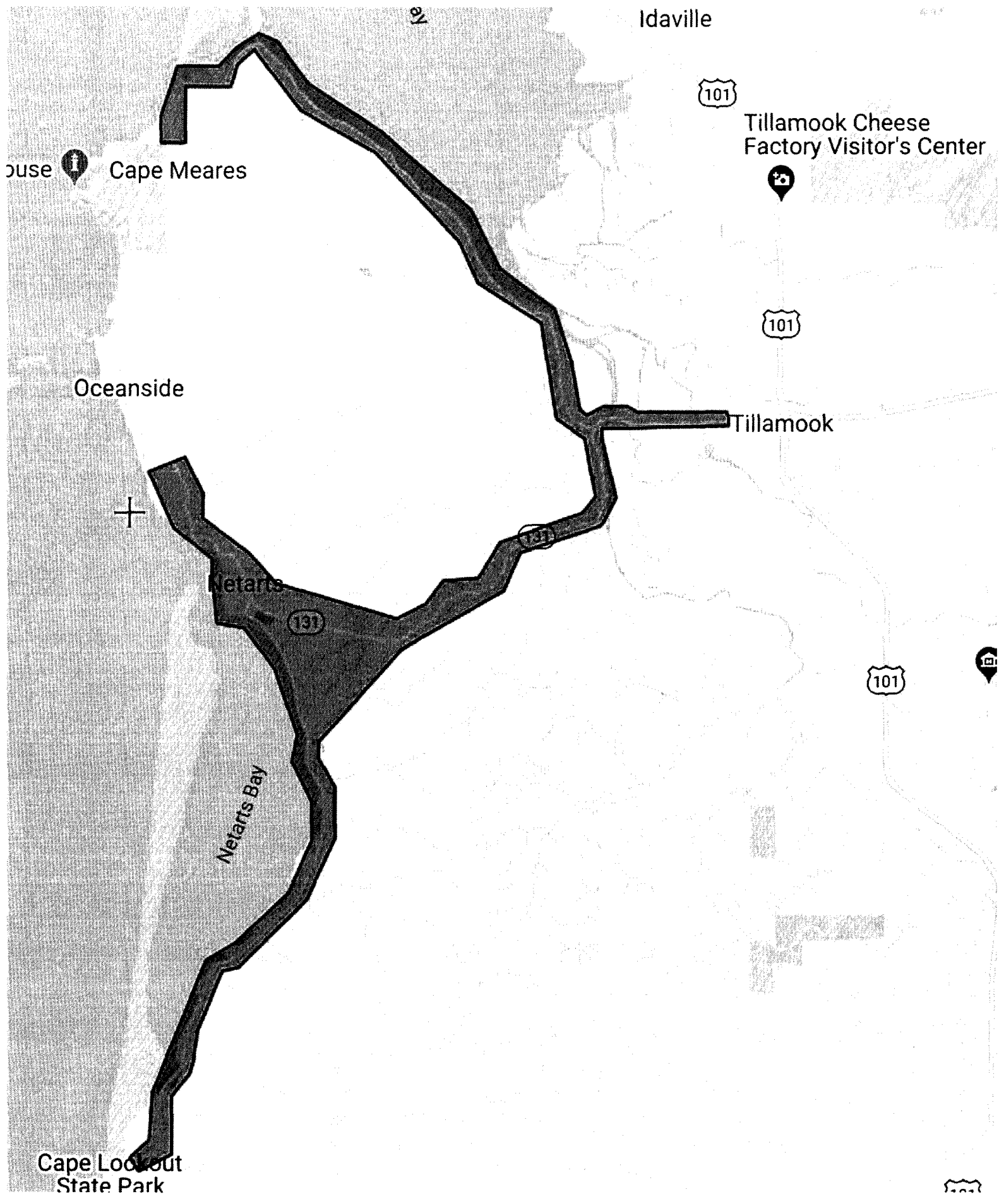
Dear Tillamook County Commissioners,

City Sanitary Service is requesting permission to start curbside commingled recycling (CCR) service in two pocket areas of Tillamook County (see exhibit 1 & 2). Residential properties must meet three criteria to be eligible for this service. 1. Have an existing garbage service account with City Sanitary Service or start one. 2. Live inside one of the pocket areas. 3. Agree to rent the 95 gallon recycling cart and pay the monthly service fee approved by Tillamook County of \$6 per month. It is our intent to expand to other areas of the county in the future if the program is well received by our customers, financially stable, and a viable market for the material continues. We currently provide this service inside the City limits of Tillamook. I have attached a flier with the materials that are currently accepted in the commingled mix. These materials can change depending on market conditions.

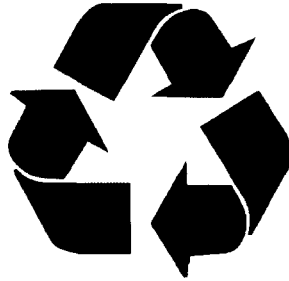

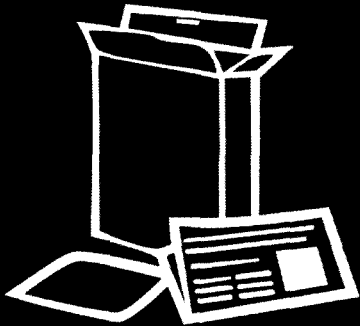

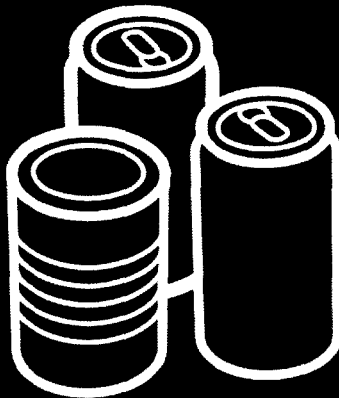

Dear Tillamook County Residential Customers,

Starting September 1<sup>st</sup> 2018 we will be taking requests for curbside commingled recycling (CCR) service in selected pocket areas of Tillamook county. If you live in the Cape Meares/Netarts area and have your trash picked up on Tuesdays or live in the Fairview/Hughey area and have trash service on Thursdays you may be eligible for curbside recycling service. You must have an active trash account or start one, live in the pocket area, and agree to pay the \$6 per month cart rental and service fee to receive the service. Recycling will be picked up on the 2<sup>nd</sup> and 4<sup>th</sup> weeks of each month on the same day as your garbage service. Please call or email to request service or with any questions you might have.
