In the Matter of Changing Rates for Municipal Solid Waste Disposal at the Pacific City and Manzanita Transfer Stations ORDER #18 - <u>085</u> SWSD #18 - <u>OIS</u> 11.78

This matter came before the Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD), on October 10, 2018, at the request of Chris Laity, Tillamook County Solid Waste Administrator. The Board being fully apprised of the records and files herein, the Board finds as follows:

- 1. In accordance with Ordinance #4, Section 5.01 B. c., the Board may by ordinance or order establish rates for disposal sites that are uniform throughout the county or different rates for each site or class of sites.
- 2. Tipping fees for municipal solid waste (MSW) disposal at the Manzanita and Pacific City Transfer Stations are established by this governing body and were last changed on March 28, 2018 by Order #18-036, SWSD Order #18-006.
- **3.** The Tillamook County Solid Waste Advisory Committee (SWAC) at its October 3, 2018 meeting voted to recommend the immediate implementation of a temporary surcharge for the acceptance (tipping) fees of trash (municipal solid waste) charged at the Pacific City and Manzanita Transfer Stations, as outlined below.
- 4. The proposed tipping fees for Municipal Solid Waste (MSW) would be:
 - A. \$79.84 per ton for franchise haulers (no change);
 - B. \$96.76 per ton for self-haulers to the Tillamook Transfer Station with a \$19.00 (up to 400 lb.) minimum fee (no change);
 - C. \$110.00 per ton for self-haulers to the Pacific City Transfer Station with a \$9.00 minimum fee (up to 164 lb.) plus a \$10.00 per ton surcharge with a \$11.00 surcharge on the minimum fee, resulting in a total cost of \$120.00 per ton with a \$20.00 minimum fee;
 - D. \$110.00 per ton for self-haulers to the Manzanita Transfer Station with a \$8.25 minimum fee (up to 150 lb.) plus a \$10.00 per ton surcharge with a \$11.75 surcharge on the minimum fee, resulting in a total cost of \$120.00 per ton with a \$20.00 minimum fee.
 - E. The surcharges would remain in effect through June 30, 2019, with the intent to revise rates effective with the new budget year beginning July 1, 2019.
- 5. The Tillamook County Board of Commissioners finds that the proposed rate will be just, fair, reasonable and sufficient to provide the proper service to the public.

NOW THEREFORE, IT IS HEREBY ORDERED that:

- 6. Effective November 15, 2018, the fees charged for the disposal of municipal solid waste (MSW) at the Tillamook County Transfer Stations shall be established as follows:
 - A. Tillamook Transfer Station (no changes):
 - i. \$79.84 per ton for franchise haulers
 - ii. \$96.76 per ton for self-haulers with a \$19.00 (up to 400 lbs.) minimum fee
 - B. Pacific City Transfer Station:
 - i. Garbage/Municipal Solid Waste: \$110.00 per ton plus a \$10.00 per ton disposal surcharge with a \$9.00 minimum fee (up to 164 lbs.) plus a \$11.00 minimum fee disposal surcharge, resulting in a total cost of \$120.00 per ton with a \$20.00 minimum fee
 - C. Manzanita Transfer Station:
 - i. Garbage/Municipal Solid Waste: \$110.00 per ton plus a \$10.00 per ton disposal surcharge with a \$8.25 minimum fee (150 lbs.) plus a \$11.75 minimum fee disposal surcharge, resulting in a total cost of \$120.00 per ton with a \$20.00 minimum fee
