In the Matter of the Adjusting Certain Fees at Tillamook County Campgrounds

This matter came before the Tillamook County Board of Commissioners on October 24, 2018 at the request of Del Schleichert, Director, Parks Department. The Board of Commissioners being fully apprised of the representations of the above-named person, and records and files herein, finds as follows:

- 1. The current fee schedule set forth in Order #13-045 needs to be revised to simplify the payment process at Tillamook County Campgrounds.
- 2. The fee adjustment set forth in this order includes State and local lodging taxes and rounded off to whole dollars.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 3. The fee adjustments shall be revised for the Tillamook County Parks Department as set forth in the attached Exhibit A, which is incorporated herein by reference be and are hereby adopted.
- 4. This order will become effective November 1, 2018.

EXHIBIT A

Tillamook County Parks Department

Currently camping fees have lodging taxes charged separately which leads to a large quantity of coins being required and confusion over amount owing when patrons attempt to pay using the honor system. There have been numerous request from Patrons asking for fees to be rounded to a whole dollar amount and simplified.

We are proposing this flat fee to simplify the payment process and help prevent confusion and frustration.

The flat fee would include the lodging taxes and would be a whole dollar amount.
