This matter came before the Tillamook County Board of Commissioners on December 2, 2020 sitting as the governing body of the Solid Waste Service District (SWSD). A request for ownership transfer of the Oceanside Sanitary Service Collection Franchise from Ken & Nonda Zwald LLC to Walker Waste Solutions LLC has been submitted by Ken and Nonda Zwald, co-owners of Ken & Nonda Zwald LLC and Robert Poppe and Ron Walker, co-owners of Walker Waste Solutions, LLC.

The Board of Commissioners being fully apprised of the records and files herein, finds as follows:

1. Section 4.15 of Tillamook County Ordinance #4 states that "A franchisee may transfer the franchisee's franchise, or a portion thereof, to other persons only upon written notice to and approval by the Board."
2. Notice of the proposed transfer has been given to Tillamook County on November 3, 2020.
3. No changes to routes or rate schedules will occur at this time but are possible during the next regularly scheduled review period.
4. The Tillamook County Solid Waste Advisory Committee at its meeting on November 10, 2020, recommended that the transfer of the franchise be approved.
5. The Tillamook County Board of Commissioners has determined that the request for the change of ownership (franchise) of "Oceanside Sanitary Service" to Walker Waste Solutions LLC meets all applicable requirements.

NOW THEREFORE, IT IS HEREBY ORDERED that

6. Oceanside Sanitary Service Solid Waste Collection Franchise be transferred to "Walker Waste Solutions LLC," effective January 1, 2021.

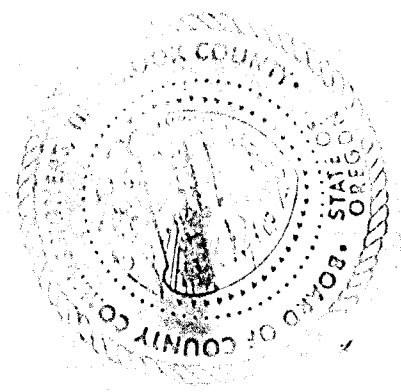







