

1. Bill Baertlein's appointment as liaison to the Tillamook County Wellness Advisory Committee expired on December 31, 2020.

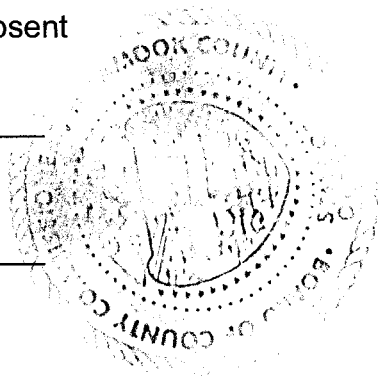
NOW, THEREFORE, IT IS HEREBY ORDERED that:


