ORDER #22-020

NOTICE OF INTENT TO AWARD A CONTRACT

This matter came before the Tillamook County Board of Commissioners on April 20, 2022 at the request of Chris Laity of the Tillamook County Public Works Department, for a notice of intent to award a contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:

- 1. Tillamook County advertised its request for proposals in the Headlight Herald, a local newspaper of general circulation, on March 15, 2022 and March 22, 2022 and in the Daily Journal of Commerce on March 16, 2022 and March 23, 2022. Therefore, notice of proposal solicitation was properly published.
- 2. Tillamook County distributed twenty-one (21) copies of its bid solicitation documents in response to all potential bidder requests for copies.
- 3. During the call for bids period, Tillamook County issued one (1) addendum addressing concerns by potential proposers or other interested persons.
- 4. Tillamook County received six (6) timely responsible bids.
- 5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the contract to the responsible bidder submitting the most advantageous, responsive bid.
- 6. The bid of BOB MCEWAN CONSTRUCTION, INC. in the amount of One Hundred Fifty-Two Thousand Five Hundred and Twenty-Three and 00/100 Dollars (\$152,523.00) for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

- 7. Notice of intent to award a contract for the Old Wheeler Mohler Road Slide Repair Project be and is hereby adopted. The board's executive assistant is directed to promptly send by e-mail, a copy of this order to the successful bidder and all plan holders who provided an address.
- 8. This notice shall constitute a final decision of Tillamook County if no written protest of the notice of award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within

seven (7) calendar days of the date of this notice of award pursuant to local contracting rules.

- 9. BOB MCEWAN CONSTRUCTION, INC. shall submit the required insurance certificates and executed contract in order that a signed contract is presented to the Board of Commissioners at its regular meeting on April 27, 2022.
- 10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.


