This matter came before the Tillamook County Board of Commissioners on July 26, 2023 at the request of Chris Laity of Tillamook County Public Works Department, for a notice of intent to award a contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:

- 1. Tillamook County advertised its call for bids in the Headlight Herald, a local newspaper of general circulation, and in the Daily Journal of Commerce on July 11, 2023. Therefore, notice of solicitation for bids was properly published.
- 2. Tillamook County distributed thirteen (13) copies of its bid solicitation documents in response to all potential bidder requests for copies.
- 3. During the call for bids period, Tillamook County received no objections or other concerns regarding the bid documents timely raised.
- 4. Tillamook County received three (3) timely responsible bids.
- 5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the contract to the responsible bidder submitting the most advantageous, responsive bid.
- 6. The bid of <u>BAYVIEW ASPHALT INC.</u> in the amount of <u>One Hundred Fifty-Six</u>
 <u>Thousand Eight Hundred Forty-Seven and 00/100 Dollars (\$156,847.00)</u> for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

- 7. Notice of intent to award a contract for the Neah-Kah-Nie Paving Project 2023 be and is hereby adopted. The board's executive assistant is directed to promptly send by e-mail, a copy of this order to the successful bidder and all plan holders who provided an address.
- 8. This notice shall constitute a final decision of Tillamook County if no written protest of the notice of award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within

- seven (7) calendar days of the date of this notice of award pursuant to local contracting rules.
- 9. BAYVIEW ASPHALT INC. shall submit the required insurance certificates and executed contract in order that a signed contract is presented to the Board of Commissioners at its regular meeting on August 2, 2023.
- 10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.
