In the Matter of Dissolving the Beaver Water District

ORDER #23-065

This matter came before the Tillamook County Board of Commissioners on October 4, 2023, at the request of Rachel Hagerty, Chief of Staff. The Board of Commissioners being fully apprised of the above-named person, the records and files herein, finds as follows:

- 1. Pursuant to ORS 198.345(1), on August 18, 2023, the Tillamook County Board of Commissioners received notice from the Office of the Oregon Secretary of State that the Beaver Water District failed for three consecutive years to file the reports required by municipal audit law.
- 2. The State's notice requests the Board initiate dissolution proceedings under the provisions of ORS 198.335 to 198.365.
- 3. Pursuant to ORS 198.345(2), on August 24, 2023, the Board of Commissioners' Office informed the Beaver Water District of the State's notice and the statutory process for dissolution, thereby initiating dissolution proceedings.
- 4. On September 24, 2023, the District provided the Board of Commissioners' Office the required District financial statement (attached hereto) prescribed in ORS 198.350.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

- 5. The public hearing prescribed in ORS 198.355 be held on November 1, 2023 at 10:00 a.m.
- 6. Notice of the public hearing shall be given by publication once each week for not less than three weeks in a newspaper of general circulation within the District.
- 7. Pursuant to ORS 198.350 and 198.355, this Order and Financial Statement be filed with the Tillamook County Clerk this 4th day of October, 2023.





Oregon Revised Statute 198.350 - Financial Statement

(1) The date of formation of the district.
