1. House Bill 2337 went into effect on September 24, 2023 allowing members of the Property Value Appeals Board to serve two-year terms.
2. Prior to September 24, 2023, members of the Property Value Appeals Board were appointed to serve one-year terms.
3. On September 13, 2023, Board Order #23-060 reappointed Stephe Poppe and appointed Gary Knowlton to the Property Value Appeals Board to serve two-year terms.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

4. Board Order 23-060 be and hereby is amended to reflect the appointment of members to the 2023-2024 Tillamook County Board of Property Value Appeals Board for one-year terms.
5. Stephe Poppe be and hereby is reappointed to the Governing Body Pool and the Non-Office Holding Pool for a one-year term on the 2023-2024 Tillamook County Board of Property Value Appeals Board.
6. Gary Knowlton be and hereby is appointed to the Governing Body Pool and the Non-Office Holding Pool for a one-year term on the 2023-2024 Tillamook County Board of Property Value Appeals Board.





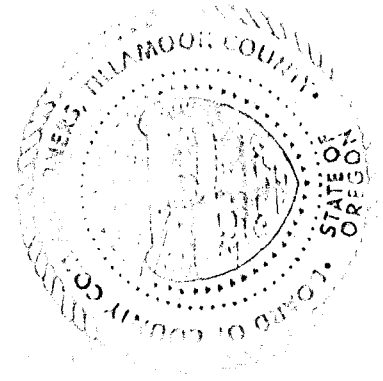
