Exhibit "A"
Landowner Right-of-Way Maintenance Agreement Standards



Zone A – Edge of Road (asphalt/gravel driving surface) to Shoulder.

- All vegetation is to be removed from shoulder area. (Spray, burn, or pull)
- Limb trees to provide a vertical sight distance, 20 feet at edge of road and 15 feet at edge of shoulder (to the front of "Zone C"). This improves sight distance, minimizes fallen limbs on the road, and increases the amount of sun on the road.

Zone B – Edge of Shoulder to Ditch

- Mow or spray to the bottom of the ditch. Water must enter the ditch unimpeded.
- Maintain clean ditches. The flow of water must not be obstructed.
- Limb to vertical clearance, 15 feet or as needed (to the back of "Zone C")

Zone C – Ditch to the Edge of Right-of-Way*

- Spray as deemed necessary to control noxious weeds or to improve sight distance.
- Brush as needed to maintain sight distance.
- Limb to vertical clearance, 15 feet or as needed (to the back of "Zone C"), but generally not past power poles.

^{*} Property owners that have a valid Landowner Right-of-Way Vegetation Maintenance Agreement may have vegetation in "Zone B/C" as long as it does not interfere with the functionality of the ditch line, impede sight distance, or create a safety hazard, as determined by the Road Foreman.
