### **WELCOME NEW MASTER RECYCLERS!**

February 17th marked the final day of Tillamook County Solid Waste's ninth Master Recycler class. "I'm so thrilled to offer this class and see people who are passionate about recycling and making a difference in their neighborhoods come together," states Sue Owens, Coordinator of the Master Recycler program. "We started the class in 2014 and as of today, have 25 certified Master Recyclers."

Class participants learned basic recycling information and the impact of a healthy recycling program. Not limited to classroom learning, students were also treated to field trips to local sights of interest such as all three County Transfer Stations and City Sanitary Service's recycle yard.

A further perk of being a Master Recycler is the annual field trip for the entire group. "Each year we try to plan a trip to places of interest outside of Tillamook County." Owens shares, "we've gone to some really interesting places and I look forward to taking the volunteers someplace where they can really see what happens after materials leave Tillamook County."

The Master Recycler class is free and only asks for 30 hours of volunteer time over the following year in exchange. This time can be utilized in many ways, helping with school outreach events, household hazardous waste events, mixing recycled paint, repairing recycle shacks, building benches and tables, and working at community event tables to name a few. "I try hard to match skills and interests with jobs that need to be done," notes Owens, "we have a lot of things to do but I won't ask anyone to do something they don't feel comfortable with or that is unsafe."

### FIGHTING BIRDS WITH FISHING LINE

Do you ever wonder why there are essentially NO seagulls at the Tillamook Transfer Station? Even though, for a garbage staging station, the transfer station is meticulously clean, there is still plenty of things to attract seagulls.

In the past, the Solid Waste Department looked for humane ways to attempt to control the seagull population at the transfer station. "The waste from so many birds was creating problems with sanitation," states David McCall, Solid Waste Program Manager, "we had to do something." When McCall was hired in 2012 the county had contracted with a falconer to deal with the gulls in a natural way. "It was very effective but also costly," notes McCall. Being resourceful, McCall started investigating alternatives.

What he found made him a laughing stock with many—until it worked. The new system is simply a "net" of heavy duty fishing line strung over the open areas of the facility. Barely visible to the human eye, it distorts the bird's vision, making them afraid to try to approach." It is very effective, humane, and affordable" adds McCall. Not only is it affordable, it's low maintenance, "It's been in place five years and we just replaced it for the first time," he adds, "it is a bit challenging to install, but not impossible with the right equipment and a few dedicated people with a little time." The replacement was made possible due to the help of some contracted help and of course, Master Recyclers. "Many of the tasks that get done in this department are done with the tremendous assistance of our volunteers," McCall adds. Next time you visit the transfer station, look up. When the light hits it just right, you can see it gleaming in the sky and rarely a seagull in sight.
